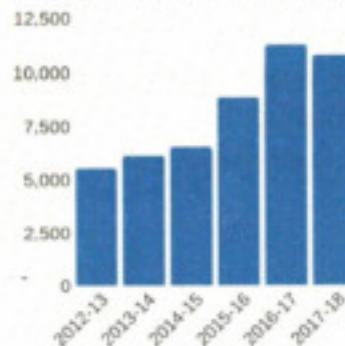

- Over 600 employees serving Marion, Johnson, Bartholomew, Monroe, Morgan and Shelby Counties

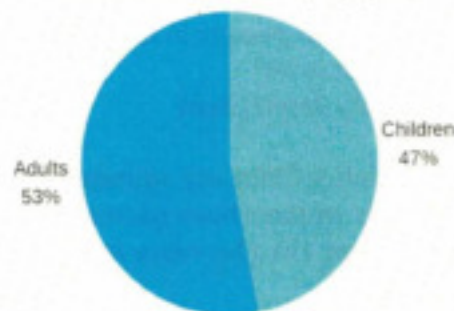
Adult & Child Health unduplicated client count

HIGHLIGHTS

FACT:

People with Serious Mental Illness have a life expectancy of 10-20 less than those without. Integrating mental health, substance abuse, and primary care services produces the best outcomes and proves the most effective approach to caring for people with multiple healthcare needs.

A&C RESPONSE:

In 2017, A&C was awarded FQHC Lookalike status and the integrated care model was adopted. We now have invested in 4 primary care clinics to help patients achieve optimal health outcomes.



HOW IS A&C FUNDED?

- A&C is largely funded by a fee for service model with their primary funding source being Medicaid
- State level funding from the Department of Mental Health and Addictions; mostly in the form of competitive grants
- State level funding from the Department of Child Services in the form of foster care per diems and fee for service driven child welfare services
- County level funding which helps to leverage Medicaid Rehab Option funding and local programming
- Private Foundation funding fills in some service gaps where other funding isn't available

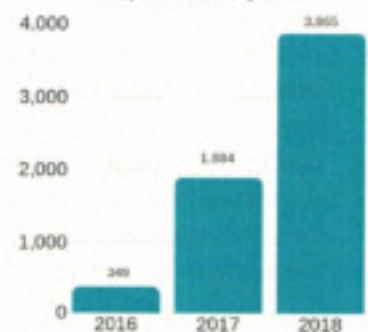
OUR MISSION

WHO DO WE SERVE?

- Our mission is to support overall health among the underserved and vulnerable populations including those who experience mental illness, chronic disease, decreased access to health care, substance abuse, homelessness, and struggles related gender identity
- As a public safety net provider, we serve everyone who requests services regardless of their ability to pay. We accept all insurances and offer a sliding fee scale.
- A&C served 10,815 unduplicated patients last fiscal year
- A&C provided 444,838 hours of service to patients last fiscal year
- A&C hosted 3,865 primary care visits in the 2017-2018 fiscal year, more than double the number from the previous fiscal year (1,884).
- 58% of A&C's clients live in Marion County, while 31% live in Johnson County.
